



Along with local dollars the DCBDD receives Federal and State funds.




# **Early Intervention**



Early Intervention is a statewide system that provides coordinated early intervention (EI) services to families with children under the age of three with developmental delays or disabilities. The federal Individuals with Disabilities Education Act (IDEA) establishes EI programs in all 50 states. In Ohio, the Department of Children and Youth serves as the lead agency for the EI program.

The DCBDD EI team works with you in your home or other places you and your family spend time to develop a coordinated plan, using your existing supports and resources—and will build upon them—to learn to enhance your child's learning and development.



# Early Detection! Meet Beau

When Beau was born he showed signs of tension. He'd been able to hold his head up but he favored only one side when rolling or curling up, and he experienced symptoms of severe colic.



With the help of the family pediatrician, Beau's family was connected with the El team! He is making great progress due to Early Intervention and therapies.

Mom said, "EI helped make all of this possible and whenever we have the chance, we tell any and every one to trust EI with their child's developmental needs."

### **Good Samaritan School**





Good Samaritan School provides educational services for students with significant needs, ages three through twenty-one. Students are enrolled through the school district in which they live. Good Samaritan School follows guidelines and regulations from Ohio Department of Education. The law requires that an Individualized Education Plan (IEP) which outlines goals, objectives and services for each student be developed. Student progress is reported quarterly with an annual review of the child's individualized education program (IEP). Students who attend Good Samaritan School are alternately assessed. The curriculum utilized by Good Samaritan School is The Unique Learning Systems Curriculum. This curriculum adheres to the Ohio Content Standards (Extended). All teachers are licensed by the Ohio Department of Education and staff participate in professional development.

Khloe started Preschool at Good Samaritan School the day after she turned 3. She had behaviors, was nonverbal and did not tolerate any type of physical contact AT ALL.

Khloe is now 9. She still attends Good Samaritan School and has received Physical, Speech and Occupational Therapy over the past 6 years. Her accomplishments are remarkable as her behaviors have decreased, she loves to talk to people and even gives out hugs. "Our family has been blessed to have Khloe attend Good Samaritan school where her Therapists, Teaching staff, and Nurse have helped shape our life for the better. They have helped Khloe gain independence in many areas and care for and teach her, even on her hardest days. They meet Khloe where she is and that is what is most important", stated Mom.

# Service and Support Administration

Defiance County Board of DD's Service and Support Administrators, or SSAs, coordinate and connect people with developmental disabilities to individualized supports in their community. SSAs get to know individuals and families and help them identify dreams for the future.

Service and Support Administrators (SSA) assist with connecting individuals with developmental disabilities to local resources while being their support for questions and services. The SSA works with those that we serve along with their providers, loved ones, and caregivers to develop an Individual Service Plan (ISP). This plan is the guidebook that outlines the individual's goals and the plan formulated to get them there. The SSA responds to the needs of those that receive services all while supporting them in their goals to help them succeed. They are caseworkers, advocates, a resource guide and overall support.

Mom says, "Since joining Special Olympics and being in every sport possible, I have watched this once struggling girl emerge into a shining star who at every practice runs off to her teammates as I hear them yell "Hey Ambree". They slap hands, hug or just smile and laugh together!"



# **Provider and Resource Agencies**
